

Lambert Auto Salvage Terms of Limited Warranty & Returns

All parts sold by Lambert Auto Salvage come with a standard 90 day parts only warranty. This warranty is valid for 90 days from the date of the original sale and does not include any labor coverage. Extended warranties, if purchased, are available on all parts and range from 6 months to 2 years. Extended warranties are parts only and does not include any labor coverage. The following terms and conditions apply to all parts purchased at Lambert Auto Salvage.

1. Lambert Auto Salvage warrants all parts to work properly and fit the requested application.
2. Lambert auto salvage may replace, repair or refund any parts under warranty or extended warranty under our discretion.
3. Extended warranties must be purchased at the time of the original sale and will be printed on the front of your invoice.
4. Extended warranties apply only to the original part that is purchased. In case of a defective part the extended warranty is used, replacement parts have a 90 day warranty and the extended warranty may be purchased again.
5. All warranties are valid for original purchaser only. Warranty is non-transferable.
6. The original receipt must be presented for returns, credits or warranty claims.
7. Lambert Auto Salvage does not cover or reimburse for the loss of time, loss of vehicle use, inconvenience, or any other consequential expenses in any of our warranties.
8. A reasonable deposit is required for orders where parts must be removed or ordered from another source.

Other Conditions

Cores: All cores must be returned complete, and rotating within 30 days of purchase for core refund.

Engines: Engine are sold as complete long blocks. Items such as, but not limited to, intake, manifolds, water pumps, wiring, sensors, thermostats, hoses, seals, timing belts, spark plugs, injectors, distributors, throttle body, ect. Are not guaranteed or covered under any warranty. It is the responsibility of the customer to ensure that these accessories are inspected and/or replaces upon installation. Proper fluid use and fluid levels must be maintained at all times. Head gaskets are warranted to be in proper working condition.

Transmissions and Transfer Cases: Gaskets, seals, and external electrical related parts are not warranted. It is the responsibility of the customer to inspect and/or replace these items at the time of installation. Transmissions must have new filters installed and be serviced to factor specifications. Proper fluid use and fluid levels must be maintained at all times. Coolant lines must be flushed and cleaned at the time of installation. All automatic transmissions purchased must be professionally installed. Receipt of installation must be provided or warranty is void.

Axle Assemblies and Differentials: Warranties applies to the gear set, housing, axle shafts, and hubs. Gaskets, seals, and external parts are not warranted. It is the responsibility of the customer to inspect and/or replace these items at the time of installation. Proper fluid levels must be maintained at all times.

Freight Costs: In the event of a warranty claim, regular freight costs are refundable. NO freight refunds will be paid on part returns or credits due to customer error.

Parts that are returned due to customer error will be charged a 20% restocking fee

All Warranties are Null and Void if:

1. The vehicle is used for racing or other forms of competition or off road recreational purposes.
2. Failure is caused by abuse, misuse, or modifications.
3. The parts fail or becomes defective due to the vehicle being involved in a collision.
4. The installed heat tab is tampered with, melted, or removed.
5. The part is not installed by a certified mechanic.

ALL warranties offered by Lambert Auto Salvage are Parts Only ! No labor coverage is offered at anytime
